

Zindica has nearly 562 medical colleges, CEET (Common Eligibility cum Entrance Test) came to existence in 2014, and these medical colleges, provide nearly 50,000-80,000 seats for the MBBS (Bachelor of Medicine, Bachelor of Surgery) course. According to the National Medical Council of Zindica (NMCZ), altogether they provide 86,649 seats.

From 2018 to 2021, 7.8 lakh students in Zindica cleared the Common Eligibility cum Entrance Test (CEET) for admission into various medical college in the country. For these 7+ lakh students, who cleared the CEET, there were just 80,000-odd medical college seats alone, in both government and private institutions combined, throughout country. WHO, prescribes the doctor patient ratio as 1:1000, whereas the doctor patient ratio is 1:1655 in Zindica. This ratio clearly shows the deficit of MBBS doctors in the country of Zindica.

Due to these reasons, many of the Zindican medical aspirants were left with the only option to opt for foreign universities to realize their medical dreams. Nearly 23,000 of Zindican students enrolled in various universities in the country of China, 18,000, in the universities of the country Ukraine, over 16,000 in the universities of the country of Russia etc., according to the official data of The Ministry of Education of Zindica.

In the year 2020, the world witnessed the worst pandemic of the century with the outbreak of the corona virus, and to curb the menace of the virus, many countries were forced to impose lockdowns. These lockdowns being a severe restriction on the free movement of the people, it thereby interrupted the entire education and business systems across the globe, and the country of Zindica was also not an exception.

Thousands of medical students had to return to their home country due to pandemic and strict COVID-19 restrictions and lockdowns. This resulted in making them unable to complete their clinical training at these respective

countries of their study. The National Medical Commission (NMC) of Zindica, has made it mandatory, to get a license to practice as a medical professional in Zindica, which requires a mandatory clinical practice by them in these respective countries of their graduation. In the absence of this license, these students will be considered ineligible to appear for Foreign Medical Graduate Examination (FMGE) in Zindica, which permits them to carry on their medical profession as a doctor in the country of Zindica.

Due to the pandemic, students from different parts of Zindica, who were pursuing their studies abroad, especially in China, Ukraine, Russia were forced to come back to Zindica before completion of their course. These students have approached the Government of Zindica for continuing their medical education which was not considered by the Zindican Government. The students have approached the Supreme Court of Zindica to get an order allowing them to pursue reminder of their studies in Zindica.

Earlier the Hon'ble Supreme Court of Zindica in its order permitted 2015-20 batch students to undergo clinical training in Zindica, and those students got provisional registration also. To increase the standards of medical examination and to ensure quality medical services to it's citizens, the government has changed its policy, and so is refusing to extend similar benefit to the students of the year 2016-21, batch.

Aggrieved by this, the medical students who came back to Zindica, without undergoing clinical training abroad has approached this Hon'ble Court.

Issues:

- 1. Denying the opportunity to pursue the studies in Zindica, whether violating the right provided under Art. 21 of the Constitution?
- 2. Insisting mandatory clinical practice abroad to the candidates who studied abroad in order to get eligibility to appear for Foreign Medical Graduate Exam in Zindica, whether violative of Art. 14 of the Constitution?
- 3. Making compulsory the Common Eligibility test for the candidates to seek admission to the MBBS course, whether violative of the rights guaranteed under the Constitution of Zindica?

Note:

- 1. The Constitution of Zindica is in parimateria to the Constitution of India.
- 2. All the legislations of Republic of Zindica are in parimateria to the legislations of Union of India.

The Counsels will be having liberty to ident fy and raise additional issues apart from the issues suggested above.

Rules & Regulations

These rules shall be referred to as '5th Thiru. Isari Velan Memorial National Moot Court Competition Rules, 2023.'

1. DATE AND VENUE

The 5th Thiru. Isari Velan Memorial National Moot Court Competition will be held virtually between23rd, 24th and25th February2023through Google Meet.

2. LANGUAGE

The official language of the Competition shall be English and all oral and written submissions must be made only in English.

3. TEAM ELIGIBILITY AND COMPOSITION

- 3.1.The Competition is open only for students pursuing LL.B three-year / five-year Law programme in India in the current academic year.
- 3.2. The participating institution must be recognized by the Bar Council of India.
- 3.3.Each team shall consist of a minimum of two or maximum of three members. No team shall consist of more than three members.
- 3.4.In a three-member team, two participants shall be designated as speakers and one as the researcher.
- 3.5.A maximum of two teams per institution will be allowed to participate in the competition.

4. REGISTRATION

- 4.1.Participating teams must fill the provisional registration form in the below mentioned link https://forms.gle/zhtz6bNVXPbTQJJg7
- 4.2.Upon provisional registration, an email with the link to final registration form containing the details of the Registration Fees Paid will be sent to the id of the student participant mentioned in the provisional registration form.
- 4.3.Before filling up the final registration form, participating teams shall have paid the registration fee.
- 4.4.Upon verification from the side of the organizers of the receipt of the said fees, the Head of the Institution of the participating team and any one of the participant will be notified

through an email about their successful registration. The said email will also contain the **Team Code** and the link of Whatsapp Official Group of the competition.

- 4.5. Each participating team shall pay a registration fee of Rs. 1,000/-
- 4.6. The registration fee shall be paid through NEFT / IMPS as per the details given below:

5. MEMORIALS

- 5.1. Each team shall prepare Memorials for both sides (1 for petitioner and 1 for respondent).
- 5.2.Petitioner's Memorial Submission shall have a bluecover page, and Respondent's Memorial Submission shall have a redcover page.
- 5.3. The team code allotted to all teams must be indicated at the top right corner of the memorials.
- 5.4.Memorials must not contain any form of identification apart from the team code. If any such identification or mark, symbol, etc., which has the effect of identifying the team is found on the memorial, then it shall result in instant disqualification of the participating
- 5.5.A penalty of 1 mark will be levied in memorial marks for the team that uses the wrong cover for the memorials.

- 5.6. The memorials shall conform to the below standards:
 - 5.6.1. Memorials should be typed in MS Word.
 - 5.6.2. The font and size of the text used in all parts of the written submissions (except the covers) must be in Times New Roman, size 12 with 1.5 line spacing.
 - 5.6.3. Footnotes must be in Calibri, size 10, and single spaced.
- 5.7. The maximum number of pages in each Memorial shall not exceed 40 pages.
- 5.8.The Memorials must be submitted through email (<u>ivmmc@velsuniv.ac.in</u>) in a pdf format on or before 15th February 2023. Late submission of memorials will attract a penalty of 1 mark from the memorial mark.

6. STRUCTURE OF THE ORAL ROUNDS

The oral rounds shall comprise of:

6.1. Preliminary Round:

6.1.1. There will be two preliminary rounds (One for Petitioner and one for Respondent side).

- 6.1.2. Teams will argue on the opted side in the first preliminary round which will be determined by way of draw of lots and for the opposite side in the second preliminary round.
- 6.1.3. Each team will get 30 minutes to present their case which includes the time for 'rebuttal' and 'sur-rebuttal'.
- 6.1.4. The division of time between the speakers is the discretion of the team members, subject to a maximum of 15 minutes for one speaker.
- 6.1.5. Before the commencement of each round, each team shall indicate to the 'court officer's to how they wish to allocate their 30 minutes.
- 6.1.6. The top 8 teams who will be qualified for Quarter-Final round will be decided based on the total win points in both the preliminary rounds.
- 6.1.7. In case of a tie, the teams having higher scores in the oral rounds(Excluding Memorial Scores) will proceed to the Quarterfinals. If the tie continues, the team having the highest speaker score will be considered being selected for the quarter-finals.

6.2. Quarter-Final Round:

- 6.2.1. The teams will argue for the opted side determined by way of draw of lots.
- 6.2.2. This will be a Knockout Round.
- 6.2.3. Each team will get 30 minutes to present their case, which includes the time for rebuttal and sur-rebuttal.
- 6.2.4. The division of time between the speakers is the discretion of the team members, subject to a maximum of 15 minutes for one speaker.
- 6.2.5. Each team shall indicate to the 'court officer' as to how it wishes to allocate its 30 minutes.
- 6.2.6. Selection for the next round will be on **Knockout** basis. Four teams will advance to the semi-final round.

6.3. Semi-Final Round:

- 6.3.1. The teams will argue for the opted side determined by way of draw of lots.
- 6.3.2. This will be a Knockout Round.
- 6.3.3. Each team will get a total of 40 minutes to present their case, which includes the time for rebuttal and sur-rebuttal.
