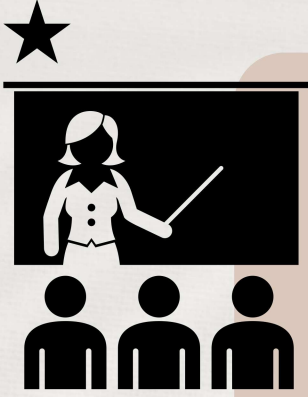


# Student Induction Program on Universal Human Values

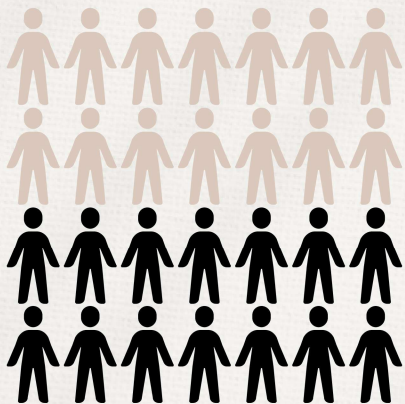
